NOTES

- 1. The KEDGE BS students receive their bachelor's degree after completing a 240 ECTS degree program. The ZHAW bachelor's degree is awarded after completing a 180 ECTS degree program. The KEDGE BS students therefore bring in an additional 60 ECTS from their prior year of study, which explains the difference in ECTS the ZHAW and KEDGE BS students complete to achieve the double degree
- 2. Master thesis supervised by ZHAW; co-evaluated by KEDGE BS using thesis evaluation grid. The Master thesis is worth 15 ECTS toward the ZHAW degree and toward the KEDGE BS degree until 2025. As of 2026, under their visa 2021, KEDGE BS will introduce changes to their degree, whereby KEDGE BS will award only 10 ECTS for the Master thesis toward their degree.
- 3. The ZHAW Business Model Innovation and Technology module will indicate 9 ECTS in the student's transcript. The ZHAW students will need to achieve all 9 ECTS. The KEDGE students will only be required to participate in and achieve 6 ECTS. The other 3 ECTS will be recognized through the achievement of credits studied during Semester 10 at KEDGE.
- 4. ZHAW students must complete the following additional requirements to earn the EBP Master Degree:
 - End of Study Professional Experience (after semester 10)
 - Pro-Act
 - Sulitest
 - Language passport
